Demand

The labour legal market in Spain has undergone significant changes in recent years, influenced by various trends. One key trend is the **increasing complexity of labour law**, which has made it challenging for businesses to navigate regulations and legal precedents. As a result, there is a growing need for legal services that can provide expert guidance and support in this area.

Another trend shaping the labour legal market is the **digitalization of the workplace**, which has created new legal challenges around data privacy, cybersecurity, and remote work. Labour-related work accounts for 20% of the total activity undertaken by the law firms, while there has been a 13% rise in labour-related activity compared to the previous year.

The data represents the percentage of labour activity related to various areas, indicating the distribution of workload among different aspects of labour law.

Based on the data provided, it appears that labour practice is quite diverse and covers a wide range of legal issues and challenges. Non-contentious/advisory work, which makes up 20% of the activity, suggests that many employers and employees seek legal advice and guidance on employment matters that can help prevent disputes and conflicts from arising.

Litigation, which accounts for 18%, indicates that there are still many disputes and conflicts that require legal intervention and resolution. It is interesting to note that industrial/trade union relations, which can often be contentious, only make up 11% of labour activity. This suggests that relationships between employers and trade unions may be improving, or that alternative dispute resolution methods are being used more frequently.

Other notable of the practice include restructuring/reorganizations and M&A and employment-related issues, which together make up 29%. This indicates that many employers are facing challenges related to changes in their business structures and operations, including mergers, acquisitions, and reorganizations.

Finally, social security and sport law each represent only 3-5% of the activity, indicating that these areas may be more specialized or focused. Criminal law and public sector employment each account for 3% or less, further highlighting the wide range of issues that fall under the umbrella of labour and employment law.
