Based on data collected by *LC Publishing's research center*, with **2,015 lawyers** active in Corporate M&A across the country and **421 partners** leading the field, the practice continues to consolidate its position as one of the most sophisticated legal segments in Italy, both in domestic and cross-border transactions.

The size of the talent pool dedicated to Corporate M&A reflects the centrality of this practice area within Italian law firms. M&A, still one of the most strategic offerings for full-service firms, requires deep sector competence, international outlook, and advanced negotiation capabilities.

A crucial element in understanding today's market is the gender distribution within these teams. While the **overall composition** of Corporate M&A departments shows a relatively balanced presence - **43% women and 57% men** - the picture changes significantly at partnership level. Only **20% of partners are women**, compared with **80% men**, highlighting a clear discrepancy between entry-mid level representation and leadership representation. Although this gender gap mirrors broader trends within professional services in Italy, it also signals a structural challenge. Law firms increasingly recognize the importance of gender-balanced leadership in improving decision-making, innovation, and client perception; however, progress remains slow and uneven across firms.

Client base and demand trends

Corporate M&A practices serve a broad spectrum of clients, and the distribution of mandates provides insight into where firms are positioning themselves. In 2025, **medium-sized enterprises account for the largest share of clients (44%)**, followed by **small enterprises (30%)**, and **large corporations (26%)**.

This composition underscores the increasing relevance of Italy's mid-market economy, traditionally driven by family-owned businesses and export-oriented manufacturing companies. The centrality of medium-

sized clients is consistent with the wave of consolidation, internationalization, and investment activity that continues to characterize Italian mid-cap M&A. Many firms report significant growth in recurring advisory relationships with this segment, supported by private equity funds increasingly targeting mid-sized businesses with strong potential for aggregation or international expansion.

Large enterprises, although representing a smaller numerical share, remain essential in terms of deal value and complexity. Meanwhile, small businesses - often involving generational transitions - continue to generate activity particularly within family business M&A and corporate restructuring.

Revenue distribution by practice area

The revenue composition across Corporate-related practice areas confirms the breadth and specialization of services offered by leading Italian law firms. Based on 2025 data, **M&A Mid-Market emerges as the largest contributor at 22%**, highlighting the strong deal flow among Italy's medium-sized companies and the continued resilience of this segment. **M&A Large Cap follows with 18%**, reaffirming its strategic importance despite a more selective pipeline of mega-deals. These transactions continue to involve sophisticated cross-border structures, complex regulatory frameworks, and interactions with global financial sponsors and multinational investors.

Family business M&A accounts for 12%, a significantly larger share than in previous years and a reminder of Italy's deep-rooted family-owned corporate landscape. **Private Equity contributes 15%**, reflecting the sustained appetite of domestic and international funds for Italian assets, supported by strong mid-market dynamics. **Advisory services represent 8%**, underscoring clients' need for ongoing strategic and regulatory guidance beyond transactional mandates.

Other relevant practice areas include:

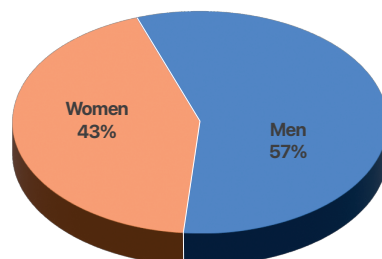
- **Equity Capital Markets (2%)**, still affected by Italy's limited IPO activity and selective capital markets conditions;
- **Corporate Restructuring (4%)**, tied to sector-specific distress and the need for operational turnaround;
- **Corporate Compliance (8%)**, increasingly driven by ESG, governance requirements, and regulatory pressures;
- **Tax M&A (3%)**, closely linked to transactional complexity and evolving tax frameworks;
- **Venture Capital (4%)**, supported by a gradually expanding innovation and startup ecosystem.

Revenue distribution by industry

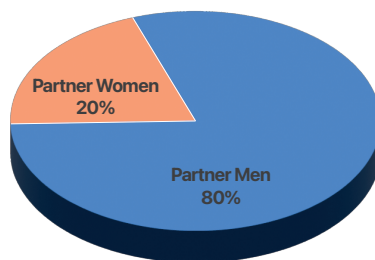
Industry data reveal a diversified client base with distinctive concentrations. **Financial institutions (15%)** and **pharma (15%)** lead as the most significant contributors to Corporate revenue, reflecting respectively the consolidation cycles in banking and insurance, and the strong resilience of the life sciences sector.

The **food & beverage (12%)** and **fashion (11%)** industries confirm Italy's traditional excellence in consumer and luxury sectors, areas where private equity and international investors remain highly active. **Media & TLC (9%)** reflects the ongoing digital transformation of Italy's communications landscape.

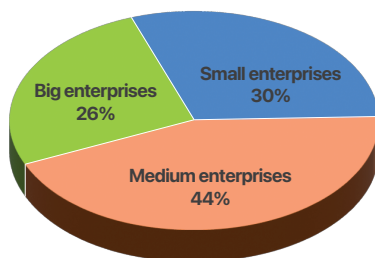
Notably, a broad **32%** of revenue comes from "Other" industries, indicating that M&A practices serve a highly diversified economic base- from industrial manufacturing to logistics, energy, and technology. This broad exposure helps firms reduce dependency on specific sectors and respond to emerging trends such as ESG-driven transactions, infrastructure development, and digital platform consolidation.

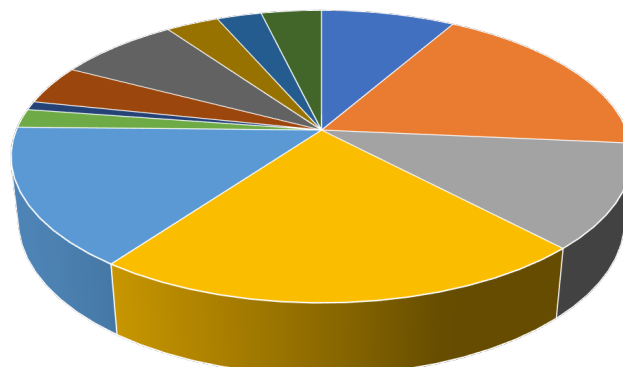
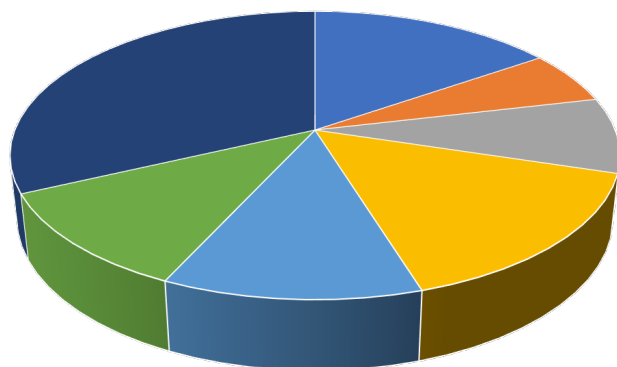

PERCENTAGE OF CORPORATE REVENUE RELATED TO INDUSTRIES

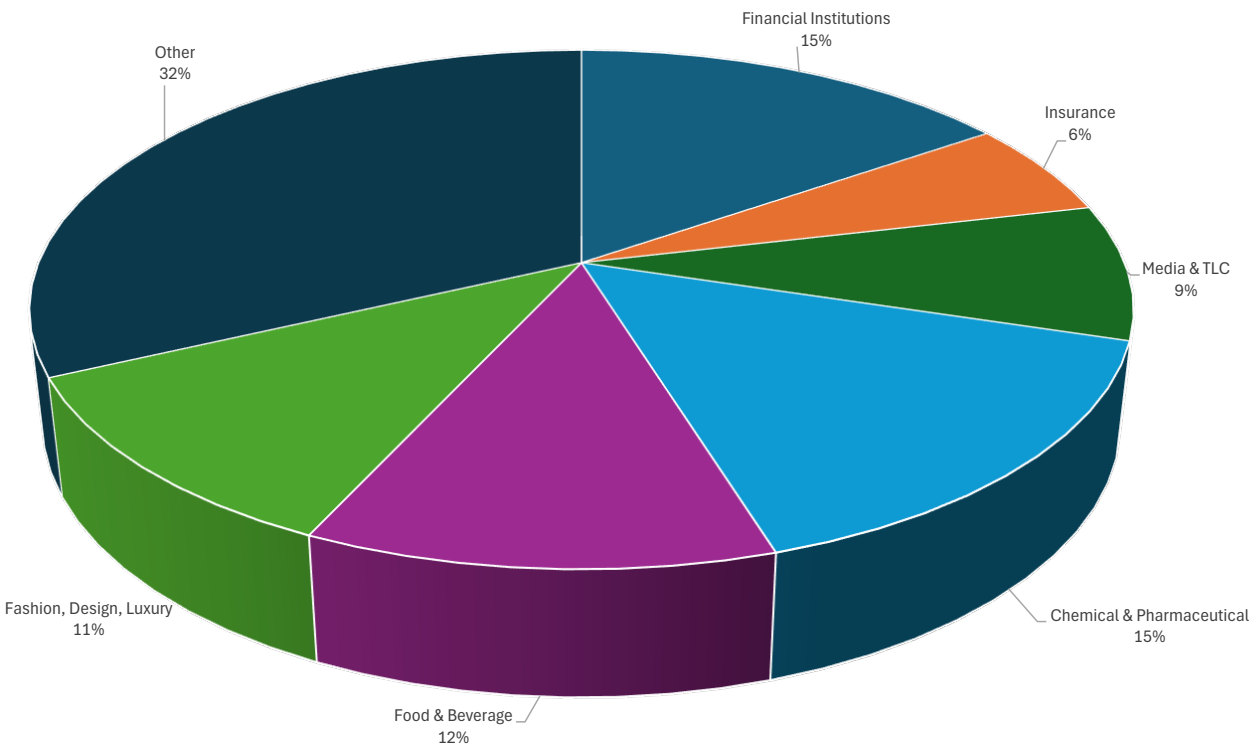
PERCENTAGE OF CORPORATE REVENUE RELATED TO PRACTICE AREAS



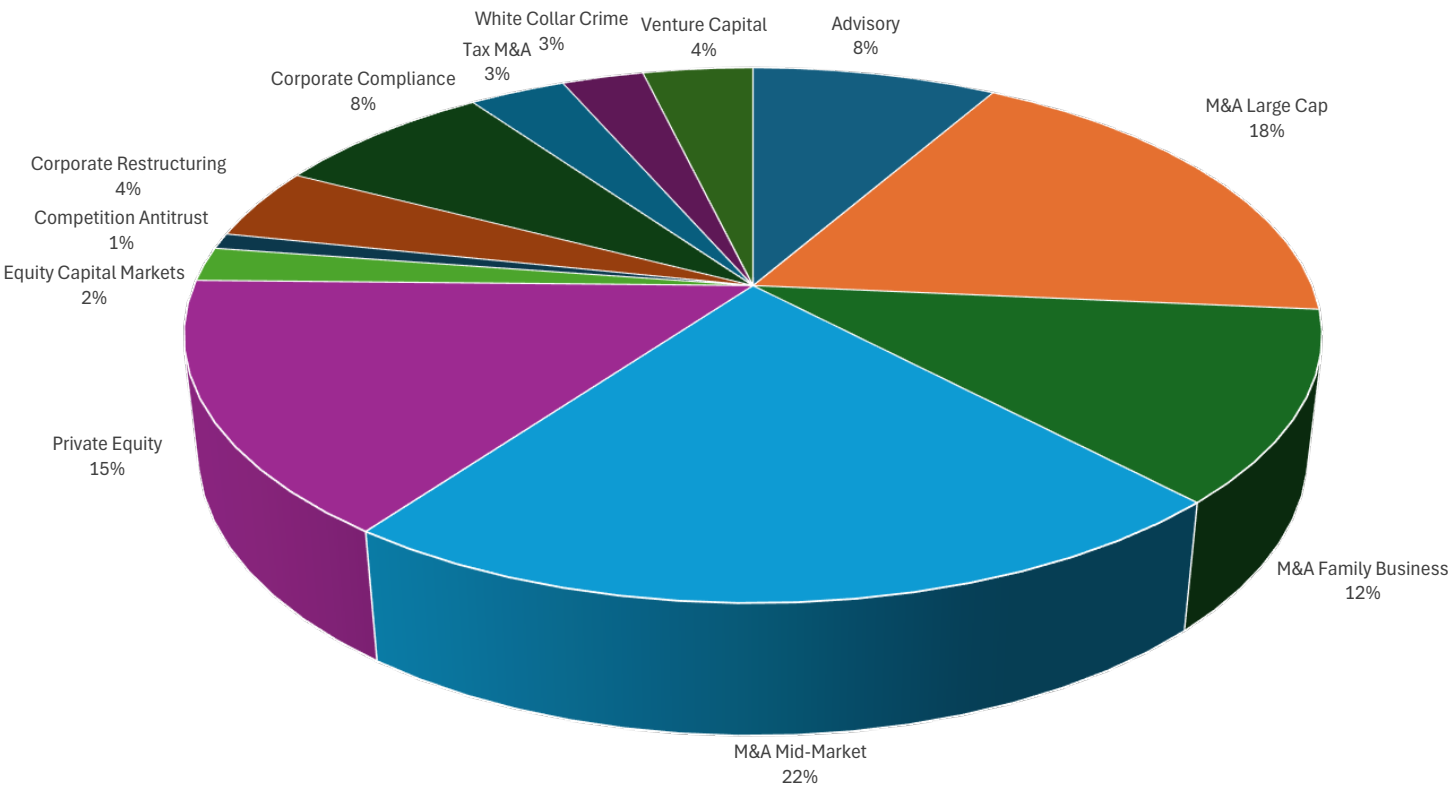
