

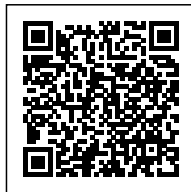

In 2018 he was appointed general counsel of the thermal division of ContourGlobal, listed on the London Stock Exchange, where he has been responsible for the legal management of eighteen jurisdictions in Europe, Africa and Latin America, and has been a member of the group's Senior Executive Committee.
