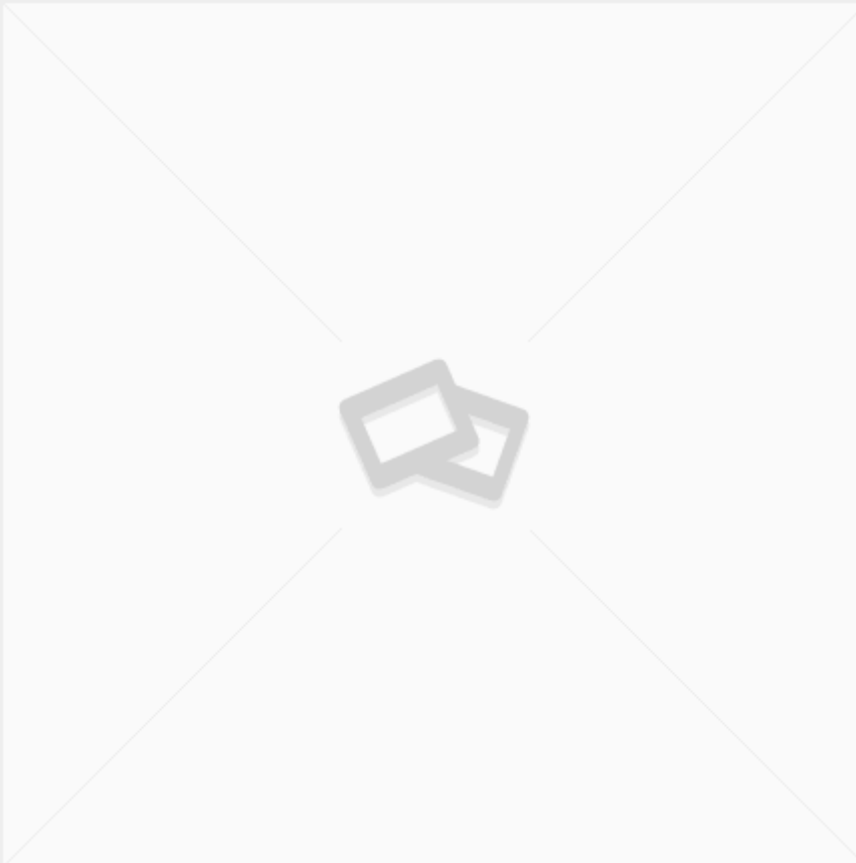


# IBERIAN LAWYER GOLD AWARDS 2018 SHORTLIST ANNOUNCED
