After the lunch break, at 14:35 it is the turn of the third and final roundtable of the Sustainability Summit, titled "Sustainability in the company: the role of the in-house". Under the moderation of **Ilaria Iaquinta**, editor-in-chief of Inhousecommunity.it and LC Publishing Group, the discussion includes **Sara Citterio**, Trussardi's group general counsel; **Serena Contu**, head of data protection at Eni gas and light; **Andrea Di Paolo**, head of legal, compliance and regulatory affairs South Europe of British American Tobacco; **Paolo Fietta**, general manager corporate & group CFO of the Il Sole 24 Ore Group; and **Guido Testa**, Orrick's Italian office leader.

After the closing of the proceedings, and a networking coffee, the Sustainability Awards ceremony begins at 7:00 pm.
