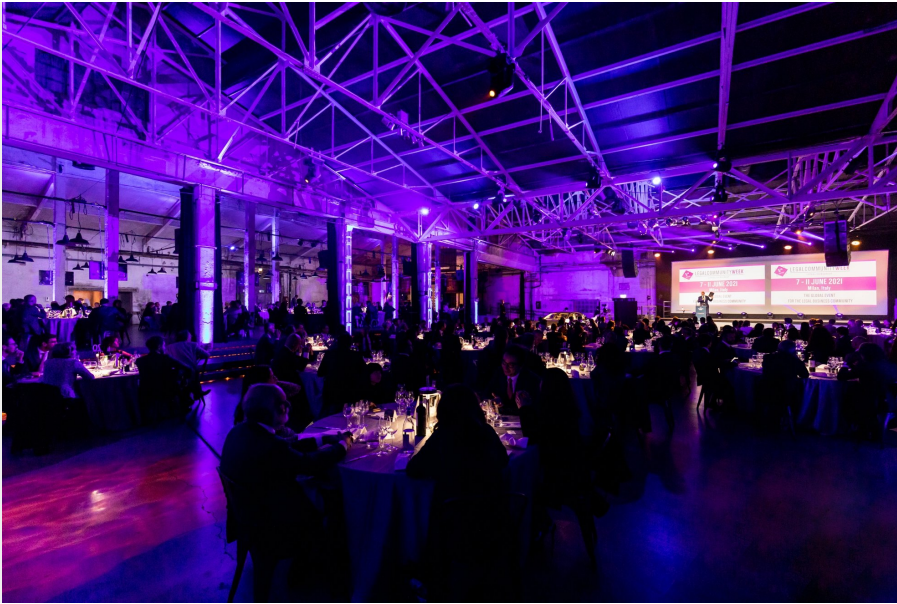


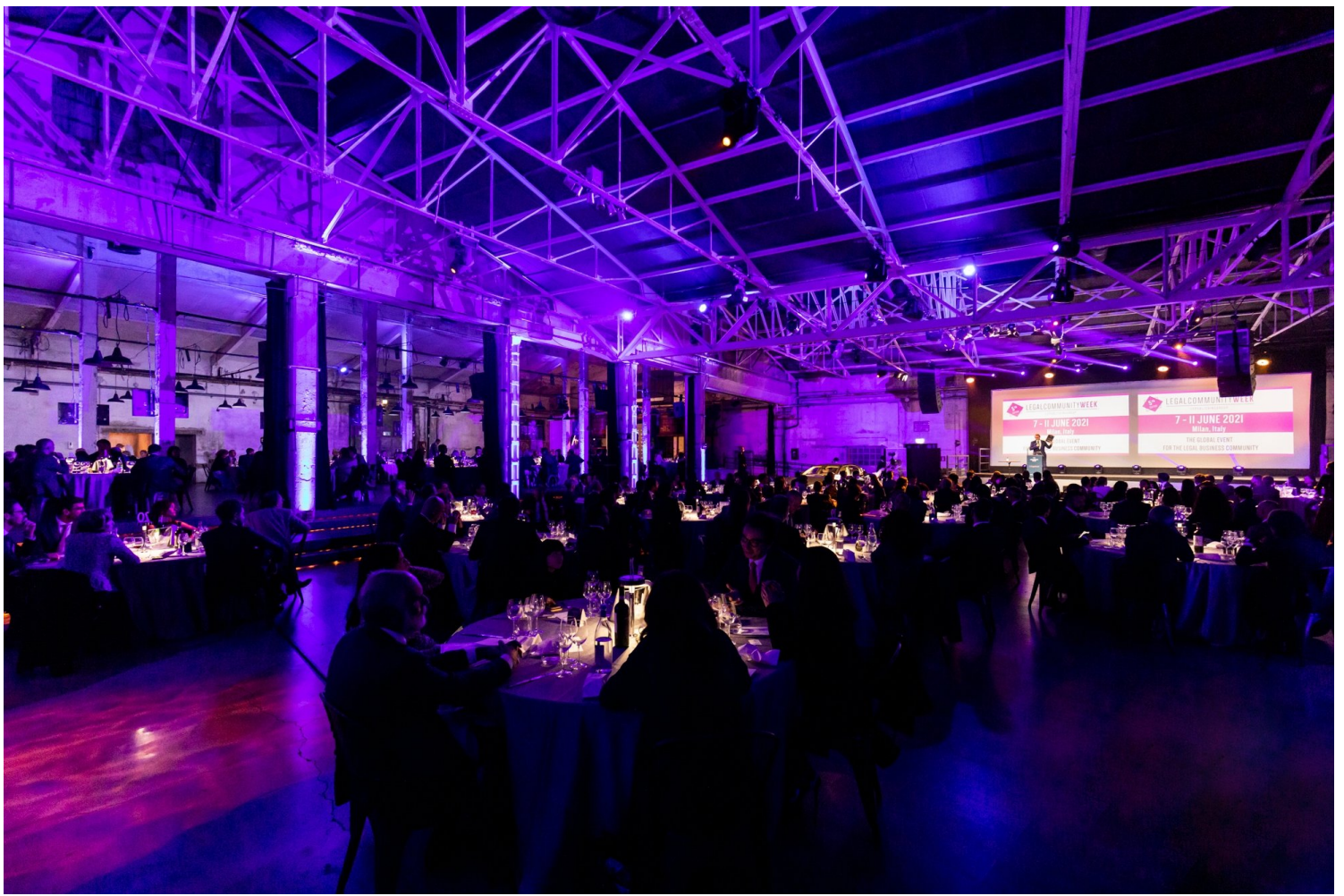
WINNERS OF INHOUSECOMMUNITY AWARDS EGYPT 2021 ANNOUNCED

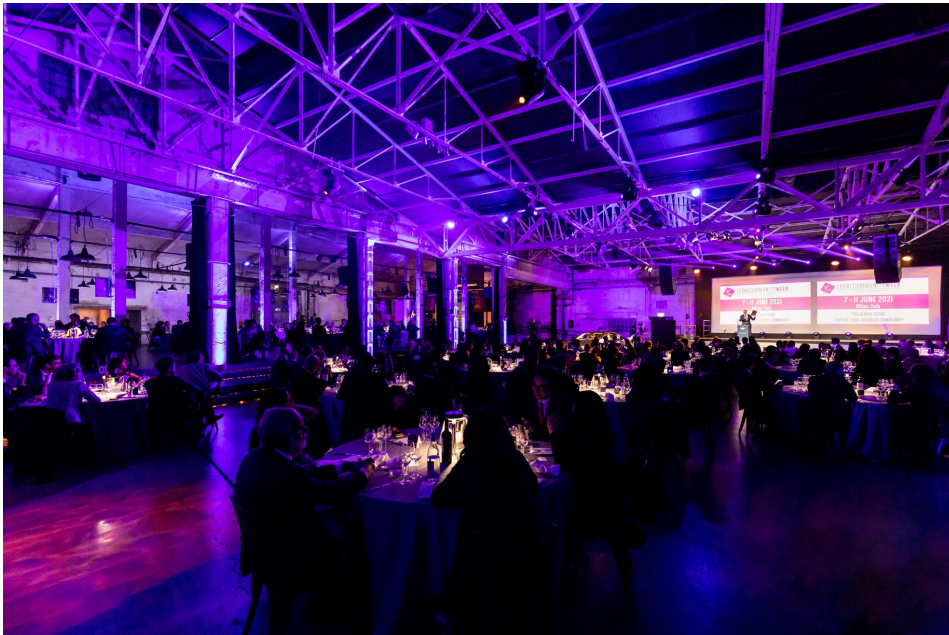
